



FEASTival on Fifth VENDOR AGREEMENT FORM

FEASTival on Fifth is a new and exciting event produced by the Meridian ACES. Local restaurants will have the opportunity to showcase dishes from around the world. The event is an opportunity to showcase your restaurant, and develop new customers.

The one-day event is scheduled for **OCTOBER 14** from **5 – 9 P.M.** Food sampling is from **5 – 7 P.M.** It will be held in downtown Meridian on 5th Street between 22nd and 23rd Avenues.

Tickets to the event will be sold in advance and at the gate.

Each attendee will receive a passport to the event. The passport must be stamped at every vendor booth in order to qualify for door prizes, which will be given at the event. An ACES volunteer will be assigned to each tent to take care of stamping passports.

EACH VENDOR WILL BE REQUIRED TO:

1. Complete the vendor form.
2. Provide sample size portions (for a minimum of 500 people) of one dish that best represents their country.
3. Sell no more than two dishes from their country with a selling price of no more than \$5.00. The dish will be a single appetizer size portion.
4. Vendor is responsible for payment of sales tax on the event.
5. Decorate booth according to culture represented.
6. Provide clean up of your area at end of event.

Each vendor will be provided one eight-foot-long table and a 10 x 10 tent. Sample cups will be provided by ACES.

SET UP MUST BE COMPLETE NO LATER THAN 3 P.M. Access to the festival area will be closed to all traffic at that point.

ELECTRICITY IS EXTREMELY LIMITED. Each vendor will need to use an alternate cooking and/or heating method.

EACH VENDOR WILL BE PROVIDED \$250 TO OFFSET THE COST OF SAMPLE FOODS. The vendor will receive a check from the ACES one week prior to the event. Vendors will be responsible for food costs for the dishes they offer for sale.
